

#### The Economic Base of Eddy County, New Mexico

#### Introduction

This report is one of 35 economic base studies prepared by the New Mexico State University's (NMSU) Arrowhead Center. Of the 35 reports, 33 describe the economic base of New Mexico's counties. There are separate reports for the State of New Mexico and for the Albuquerque Metropolitan Statistical Area (MSA). New Mexico has three additional MSAs (Las Cruces, Santa Fe, and Farmington) all of which are single county MSAs; separate reports for these MSAs were not prepared. The reports have been prepared under the direction of James Peach. Erin Sumner and Theophilus Djaba, graduate students in the NMSU Doctorate in Economic Development program, did much of the work on the updates. Comments and suggestions are welcome and are to be sent to jpeach@nmsu.edu. Our intent is to update these reports on an annual basis.

An economic base study is a descriptive tool used to analyze the composition of the local economic activity. Economic base studies are often conducted to help guide local economic development activities and to help economic development officials make decisions such as what type of firms they should attempt to attract to local areas. Economic base studies can also assist local and regional businesses to better understand local and export product markets.

The specific purposes of economic base studies include:

- Understand regional economic growth
- Make short and long term forecasts
- Identify potential growth sectors
- Identify potential problem areas

According to economic base theory, any local economy may be divided into basic and non-basic industries. The economic base theory also suggests that economic growth depends on sectors that export goods and services out of the region (basic industries), as opposed to those businesses whose services remain local (non-basic industries). Basic industries promote local economic growth by bringing jobs and income into the local economy. Non-basic industries serve local residents and provide support to basic industries.

An industry classified as basic in one region may be identified as non-basic in another region.

One common means of identifying local basic activity is through the use of location quotients (LQs). LQs are calculated as a single industry's percent of total local employment divided by that industry's percent

of total state or national employment. For example, an LQ for a single New Mexico industry (industry j) may be calculated as follows:

LQ = (Employment in industry j in NM / total employment in NM)
(Employment in industry j in US / total employment in US)


The LQ serves to illustrate the relative importance in the level of the local employment of that sector with respect to the benchmark economy, as the state or national economy. A LQ greater than 1.0 indicates that a particular industry employs proportionately more workers locally than it does at the state or national level. Conversely, a LQ of less than 1.0 indicates that the industry of note employs fewer workers locally as compared to the state or national average. In this report, LQs are calculated and analyzed for the industries within Eddy County with national employment as the basis for comparison (see Table 1). Additionally, LQs using employment for the state of New Mexico as the benchmark are included (see Table 2). For the purposes of this report, basic industries are identified using general knowledge about the structure of the local economy combined with LQs greater than 1.0. LQs are described for the most recent year for which data were available and the four years preceding (2013-2017). The economic data used in this report are from the U.S. Department of Commerce, Bureau of Economic Analysis (BEA) and the data can be found at www.bea.gov.

#### **Eddy County, New Mexico**


Eddy County is located in southeastern New Mexico and encompasses 4,175.73 square miles, or 3.44 percent of the land area in New Mexico. The population of Eddy County in 2017 was 56,997, or 2.72 percent of the state total, ranking 11<sup>th</sup> in the state of New Mexico in terms of population. Between 2013 and 2017, the population of Eddy County increased by 2.66 percent. The City of Carlsbad, with a population of 28,774 in 2017, accounted for 50.48 percent of the population of Eddy County (U.S Census Bureau, 2018). For comparison purposes, New Mexico's population increased by 0.03 percent and the United States population increased by 2.88 percent between 2013 and 2017.

Per capita personal income in Eddy County in 2017 was \$48,280, ranking 3<sup>rd</sup> in the state in terms of per capita income. Per capita income for Eddy County was 121.58 percent of the state's per capita personal income (\$39,709) and 93.33 percent of the national average (\$51,731) (See Figure 1 and 2). Between 2013 and 2017, the growth rate of per capita income in Eddy County increased by 0.89 percent, substantially lower than the state growth rate (13.21) and the nation (15.34) for the same period.

Total employment in Eddy County in 2017 was 36,052. Between 2013 and 2017, total employment in Eddy County increased 4.63 percent, higher than the state which had an increase in

employment of 2.08 percent and lower than the nation which had a 7.57 percent increase. The employment to population ratio for Eddy County was 0.63, compared to the state (0.52) and the nation (0.60).

In 2017, 86.33 percent of all workers in Eddy County were employed in the private sector, while 11.35 percent were employed in Government and government enterprises, and 2.32 percent were accounted for in Farm employment. Within the private sector, the industries with the highest percentages of total employment included: Mining (22.72), Retail trade (9.08), Health care and Social assistance (8.26), and Construction (7.55). Government employment is largely concentrated at the local government with 7.36 percent of total employment. Federal/civilian, military, and state government employment each accounted for 1.92, 0.40, and 1.67 percent of total employment respectively. Employment for Eddy County by sector is displayed in Table 3.

#### Basic and Non-Basic Industries in Eddy County, New Mexico

Table 1 contains LQs for Eddy County from 2013 and 2017 calculated using data for the United States as the basis of comparison. Table 2 contains LQs for Eddy County from 2013 and 2017 calculated with respect to the state of New Mexico. For the purposes of this report, a LQ greater than 1.0 with respect to U.S. employment is considered a basic industry. The sectors with an LQ greater than 1.0 have been shaded.

The pronounced importance of Mining within the private sector is represented by the highest LQ for Eddy County (29.49) in 2017. Mining is considered a basic industry in this county. The mining sector has historically been an important economic sector for Eddy County, with LQs above 27.75 for all years considered here. The mining industry in Eddy County includes potash, oil, natural gas extraction, sulfur, salt and gravel.

For 2017, all other industries in Eddy County have relatively low LQs compared to its LQ for mining. Farm employment (1.73) is considered a basic industry for Eddy County. Transportation and warehousing (1.10) is also considered a basic industry for Eddy County. Other industries with LQs above 1.0 include: Utilities (2.16) and Construction (1.39). However, the later industries are considered as non-basic industries for Eddy County.

The entry labeled Government and government enterprises is the aggregate figure of all government levels listed as government categories. For Eddy County, Federal/civilian employment with an LQ of 1.32 is considered a basic industry. Military and State Government in Eddy County both had LQs lower than 1.0 and are not considered basic industries. In 2017, Local government for Eddy County had a

LQ of 1.01. However, local government is generally categorized as non-basic given that local governments collect taxes from residents to provide for the services to the community, including employment. Following this practice, local government for Eddy County will be considered non-basic industry.

In brief, the data and analysis suggest that for 2017, the following industries should be considered basic industries in Eddy County:

- 1. Mining, accounted for 8,192 jobs.
- 2. Farm employment, accounted for 837 jobs.
- 3. Transportation and warehousing, accounted for 1,553 jobs.
- 4. Federal, civilian accounted for 692 jobs.

It is common in economic base studies to calculate an export-base employment multiplier. This employment multiplier is obtained by dividing total employment by total employment in the basic sectors. In the case of Eddy County, the multiplier is equal to 3.20 (36,052/11,274). This ratio suggests that the addition of each basic sector job in Eddy County would be associated with additional 3.20 non-basic sector jobs. The export base multiplier (3.20) calculated above reinforces the importance of basic (exporting) industries to the economy of Eddy County. In general terms, this employment multiplier is not to be compared to employment multipliers included in economic impact analysis tools including RIMS, REMI, and IMPLAN. In the case of Eddy County, potential double counting occupation may result in an upward bias of the multiplier given that farm proprietors often have more than one occupation.

Local economic development policy actions such as the creation of industrial parks, tax abatement and financing, and workforce development projects are often used by local communities to expand an area's economic base. The development of a community economic development plan is to include the appropriate combination of policies, which often result from public and private sector interaction.

#### **Changes from Prior Year**

This document has been revised to reflect data figures obtained from the BEA for the economic data and the U.S. Census Bureau for population data. Between 2016 and 2017, the population for Eddy County decreased by 0.80 percent, from 57,456 in 2016 to 56,997 in 2017. From 2016 to 2017, per capita income increased by 3.39 percent, from \$46,698 in 2016 to \$48,280 in 2017. Total employment increased by 1,048 jobs or 2.99 percent.
