

### The Economic Base of Rio Arriba County, New Mexico

#### Introduction

This report is one of 35 economic base studies prepared by New Mexico State
University's (NMSU) Arrowhead Center. Of the 35 reports, 33 describe the economic base of
New Mexico's counties. There are separate reports for the State of New Mexico and for the
Albuquerque Metropolitan Statistical Area (MSA). New Mexico has three additional MSAs (Las
Cruces, Santa Fe, and Farmington), all of which are single county MSAs; separate reports for
these MSAs were not prepared. All 35 reports may be found at

The reports have been prepared under the direction of James Peach. Erin Sumner, a graduate student in the NMSU Doctorate of Economic Development program, did much of the work on the updates. An economic base study is a descriptive tool used to analyze the composition of local economic activity. Economic base studies are often conducted to help guide local economic development activities and to help economic development officials make decisions such as what type of firms they should attempt to attract to local areas. Economic base studies can also help local and regional businesses better understand local and export product markets.

The specific purposes of economic base studies include:

- Understand regional economic growth
- Make short and long-term forecasts
- Identify potential growth sectors
- Identify potential problem areas

According to economic base theory, any local economy may be divided into basic and non-basic industries. This theory also suggests that economic growth depends on sectors that export goods and services out of the region (basic industries), as opposed to those businesses whose services remain local, (non-basic industries). Basic industries promote local economic

growth by bringing jobs and income into the local economy. Non-basic industries serve local residents and provide support to basic industries.

An industry classified as basic in one region may be identified as non-basic in another region. One common means of identifying local basic activity is through the use of location quotients (LQs). LQs are calculated as a single industry's percent of total local employment divided by that industry's percent of total state or national employment. For example, an LQ for a single New Mexico industry (industry j) may be calculated as follows:

The LQ serves to illustrate the relative importance in the level of the local employment of that sector with respect to the benchmark economy, state or national. An LQ greater than 1.0 indicates that a particular industry employs proportionately more workers locally than it does at the state or national level. Conversely, an LQ of less than 1.0 indicates that the industry of note employs fewer workers locally as compared to the state or national average. In this report, LQs are calculated for industries within Rio Arriba County with the national employment as the basis for comparison (see Table 1). Additionally, LQs using employment for the state of New Mexico as the benchmark are included (see Table 2). In this report, basic industries are identified utilizing general knowledge about the structure of the local economy combined with LQs greater than 1.0. LQs are described for the most recent year for which data were available and for the four preceding years (2014-2018). The data used in this report are from the U.S. Department of Commerce, Bureau of Economic Analysis (BEA) which can be found at <a href="https://www.bea.gov">www.bea.gov</a>.

## **Rio Arriba County, New Mexico**

Rio Arriba County is located in northwestern New Mexico and contains 5,860.84 square miles, or 4.83 percent of the land area in New Mexico. The population of Rio Arriba County in 2018 was 39,006, or 1.86 percent of the state total, ranking 13<sup>th</sup> in New Mexico in terms of population. The Town of Española, with a population of 10,090 in 2018 represented 25.87 percent of the population of Rio Arriba County. Between 2014 and 2018, the population of Rio Arriba County decreased by 1.84 percent. During the same period, New Mexico's population increased by 0.24 percent and the United States' population increased by 2.76 percent.





Figure 1. Per Capita Personal Income: Rio Arriba County (2018)

Per capita personal income in Rio Arriba County was \$34,582 in 2018. Per capita income for Rio Arriba County in 2018 was 83.11 percent of the corresponding state figure (\$41,609) and 63.52 percent of the national average (\$54,446) (See Figures 1 and 2). The percent growth of per capita income in Rio Arriba County between 2014 and 2018 was 13.07 percent, which was higher than the state's (11.91) and but lower than the nation's (15.70) growth rate for the same period.





Total employment in Rio Arriba County was 15,707 in 2018. Between 2014 and 2018, total employment in Rio Arriba County increased by 0.35 percent, while the state's total employment increased by 2.93 percent and the nation's employment increased by 7.79 percent for the same period. The Rio Arriba County employment to population ratio was 0.40 in 2018, compared to the state ratio (0.53) and the nation's ratio (0.61). This ratio represents a low rate of the population being employed in the county.

In 2018, 58.44 percent of Rio Arriba County was employed in the Private sector, while 29.40 percent was employed in Government and Government Enterprises and 12.16 percent worked in Farm employment. The industries with the highest percentages of total employment included: Healthcare and Social Assistance (11.96 percent), Retail Trade (8.81 percent), and Accommodation and Food Services (7.01). Within the public sector, Local government was the largest employer with 22.61 percent of total employment; State employment accounted for 4.45 percent, Federal/civilian accounted for 1.71 percent and Military for 0.62 percent. Employment for Rio Arriba County by sector is displayed in Table 1.

## Basic and Non-Basic Industries in Rio Arriba County, New Mexico

Table 2 contains LQs for Rio Arriba County from 2014 to 2018 calculated using data for the United States as the basis of comparison. Table 3 contains LQs for Rio Arriba County from 2014 to 2018 calculated with respect to the state of New Mexico. For the purposes of this report, an LQ greater than 1.0 with respect to the U.S. employment is considered as a basic industry. The sectors with an LQ greater than 1.0 have been shaded.

The importance of the Agricultural sector, here defined as Farm employment and Forestry, Fishing, and Related Activities is reflected in high LQs for both of these industries. Farm employment had an LQ of 9.37, with LQs greater than 8.62 for all years considered. Forestry, Fishing, and Related Activities had an LQ of 2.41 in 2018 and LQs greater than 1.99 for all years considered. The Agricultural sector for Rio Arriba (Farm employment and Forestry, Fishing, and Related Activities), is considered a basic sector.

Arts, Entertainment, and Recreation is also considered as a basic economic activity in Rio Arriba County. This sector had an LQ of 1.19 in 2018, reflecting the substantial artist community in and around Española. Additionally, Rio Arriba County is home to Heron Lake State Park, Vado Lake State Park, and numerous attractions in and around Chama including the Cumbres and Toltec Scenic Railroad. Because these attract tourists from nearby Santa Fe and Taos counties, the Arts, Entertainment, and Recreation industry is considered a basic economic sector for this analysis.

Healthcare and Social Assistance had an LQ of 1.06 in 2018. This LQ reflects the employment base of Rio Arriba's two medical centers, Los Alamos Medical Center and Española Hospital, both located in Española. Though the Healthcare and Social Assistance industry is often categorized as a non-basic industry, considering these hospitals' importance in serving several neighboring counties, this sector is considered as part of the basic economic base of Rio Arriba County.

Mining had an LQ of 2.07 in 2018. This industry's LQ is considerably higher in 2018 than in each of the previous years considered and will be considered a basic industry in Rio Arriba County.

The other sector with an LQ above 1.0 in 2018 included Utilities (2.47). Nevertheless, this industry in Rio Arriba County is to be considered as non-basic or a support industry.

The entry labeled Government and Government Enterprises is the aggregate figure of all government levels listed as government categories. All government sectors, with the exception of Military employment, had LQs greater than 1.0 in 2018. State government had an LQ of 1.66 in 2018 and had LQs greater than 1.64 in all years considered. State government reflects the employment base of the District Eleven New Mexico State Police and the New Mexico Environmental Improvement Office, both located in Española. Federal/civilian employment had an LQ of 1.21. This industry reflects the employment base of the East Rio Arriba Soil and Water Conservation District Office and the U.S. Rural Development Office, as well as Bandelier National Monument. For this analysis, Federal/civilian and State government employment are considered as basic economic activities. Local government had an LQ of 3.16 in 2018. However, local government is generally categorized as non-basic given that all local governments collect taxes from residents to provide for the services to the community, including employment. Following this practice, local government for Rio Arriba County will be considered as a non-basic industry.

The data and analysis suggest that in 2018 the following industries should be considered basic industries in Rio Arriba County:

- 1. The Agricultural sector, including Farm employment (1,910) and Forestry, Fishing, and Related Activities (183), accounted for 2,093 jobs.
- 2. Arts, Entertainment, and Recreation, accounted for 437 jobs.
- 3. Healthcare and Social Assistance, accounted for 1,878 jobs.
- 4. Mining, accounted for 219 jobs.
- 5. State government employment, accounted for 699 jobs.
- 6. Federal/civilian employment, accounted for 269 jobs.

It is common in economic base studies to calculate what is known as an export-base multiplier. This multiplier is obtained by dividing total employment in Rio Arriba County by basic sector employment. In the case of Rio Arriba County, the multiplier is equal to 2.81

(15,707/5,595). This ratio suggests that the addition of each basic sector job in Rio Arriba County would be associated with an additional 2.81 non-basic sector jobs. The export base multiplier (2.81) calculated above reinforces the importance of basic (exporting) industries to the economy of Rio Arriba County. In general terms, this employment multiplier is not to be compared to employment multipliers included in economic impact analysis tools including RIMS, REMI, and IMPLAN. In the case of Rio Arriba County, potential double counting occupation may result in an upward bias of the multiplier given that farm proprietors often have more than one occupation.

Local economic development policy actions such as the creation of industrial parks, tax abatement and financing, and workforce development projects are often used by local communities to expand an area's economic base. The development of a community economic development plan is to include the appropriate combination of policies, which often result from public and private sector interaction.

# **Summary of Changes from Prior Year**

This document has been revised to reflect data figures obtained from the BEA for the economic data and the U.S. Census for population data. The population of Rio Arriba County in 2018 was 39,006, a decrease of 0.47 percent from the population of 39,191 in 2017. Per capita personal income in Rio Arriba County in 2018 was \$34,582, an increase of 4.53 percent from \$33,084 in 2017. Total employment increased by 0.01 percent, an increase of two jobs between 2017 and 2018.
