

Executive Summary

Since 2012, Arrowhead Center at New Mexico State University (NMSU) has sponsored the preparation of economic base studies for each New Mexico county, the Albuquerque Metropolitan Statistical Area (MSA), and the entire state of New Mexico. Base studies are released as a public service to help businesses, economic developers, policymakers, government officials, and the general public better understand key industries that contribute to the economic base of their local economies.

This report is one of 35 economic base studies prepared by Arrowhead Center. Of the 35 reports, 33 describe the economic bases of New Mexico's counties. There are separate reports for the State of New Mexico and the Albuquerque MSA. New Mexico has three additional MSAs (Las Cruces, Santa Fe, and Farmington), all single-county MSAs; separate reports have not been prepared. ΑII 35 reports be found can at arrowheadcenter.org/economic-and-policy-studies/.

The reports were prepared under the direction of Kramer Winingham and were based on prior reports overseen by James Peach. Hayford Danso and Abdul Khaliq, graduate students in NMSU's Doctor of Economic Development (DED) program, did much of the work on the updates. In brief, the data and analysis suggest that for 2023, the following industries should be considered base industries in McKinley County:

★ Retail Trade: 3,151 jobs

★ Accommodation and food services: 2,680 jobs

★ Health care and social assistance: 3,295 jobs

★ State Government: 531 jobs

★ Federal Government: 2,304 jobs

★ NAICS 33991 Jewelry and silverware manufacturing: 135 jobs

★ NAICS 42394 Jewelry, watch, precious stone, and precious metal merchant wholesalers: 186 jobs

★ NAICS 48599 Other transit and ground passenger transportation: 123 jobs

★ NAICS 51611 Radio broadcasting stations: 30 jobs

Based on this analysis, the export base multiplier for McKinley County in 2023 was found to be 1.59 (19,823/12435). This ratio suggests that the addition of one (1) base industry job in McKinley County would increase total jobs in the community by 1.59. The export base multiplier (1.59) calculated above reinforces the importance of base (exporting) industries to the economy of McKinley County.

Methodology

An economic base study is a descriptive tool used to analyze the composition of local economic activity and identify regional competitive advantages. Economic base studies are often conducted to help guide local economic development activities and help economic development officials make data-driven decisions about what type of firms they should attempt to attract to local areas. Economic base studies can also help local and regional businesses better understand the local and export product markets.

The specific purposes of economic base studies include:

- Understanding regional economic growth and competitive advantages
- Making short and long-term forecasts
- Identifying potential growth sectors
- Identifying potential problem areas

According to economic base theory, any local economy may be divided into base and non-base industries. The economic base theory also suggests that economic growth depends on sectors that export goods and services from the region (base industries) rather than businesses whose goods and services remain local (non-base industries). Base industries promote local economic growth by bringing jobs and income to the local economy. Non-base industries serve local residents and support base industries.

An industry classified as a base in one region may be identified as a non-base in another. A standard way to identify local base activity is to use location quotients (LQs). LQs are calculated as a single industry's percentage of total local employment divided by the industry's total state or national employment percentage. For example, the LQ for a single New Mexico industry (*industry*) be calculated as follows:

(Employment in *industry* in NM / total employment in NM)

(Employment in *industry* in the US / total employment in the US)

The LQ illustrates the relative importance of the level of local employment in that sector concerning the benchmark economy, for example, state, regional, or national. An LQ greater than 1.0 indicates that a particular industry employs proportionately more workers locally than it does in the benchmark economy, which indicates a competitive advantage for a specific industry in the region. Conversely, an LQ of less than 1.0 indicates that the

industry of note employs fewer workers locally than the national average. Industries with LQs greater than 1 may have greater growth potential than other industries because their competitive advantage allows them to compete in broader markets than non-base industries, serving only local customers. Industries with LQs less than 1 can be interpreted as economic leakages in that local customers purchase goods and services from businesses located outside the region. This can indicate an opportunity to reduce economic leakages by growing non-base industries; however, it also signals that customers are seeking goods and services from these industries in other regions due to a lack of availability or competitiveness at the local level.

This report calculates LQs for industries within McKinley County using national employment as the basis for comparison, shown in Tables 8-13. For this report, base industries are identified utilizing general knowledge about the structure of the local economy combined with LQs greater than 1.0. LQs and other data points are included for the most recent year for which data are available and the four years preceding, which for most data points is 2019-2023. Industry classifications are presented for various levels of detail using the North American Industry Classification System (NAICS), the standard used by U.S. government statistical agencies to classify business establishments for collecting, analyzing, and publishing statistical data related to the U.S. business economy.²

The data points used in this report were gathered from the Bureau of Labor Statistics (BLS) Quarterly Census of Employment and Wages (QCEW)³, Bureau of Economic Analysis (BEA) Personal Income by County⁴, and U.S. Census Bureau⁵ American Community Survey and Census Bureau Profiles.

Overview

McKinley County is bordered by San Juan, Cibola, Sandoval counties in New Mexico, and Apache County in Arizona. McKinley County has a total land area of 5,455 square miles, of which 5.5 square miles (0.1%) are covered by water.⁶ The population of McKinley County in 2022 was 72,073, or 3.42% of the state total, and the City of Gallup, with a population of 21,692 contained 30.1% of McKinley County's population in 2022.⁷

McKinley County's population has decreased by 2% from 72,849 in 2018 to 72,073 in 2022, as shown in Table 1.9 Comparatively, New Mexico's population increased by 1% for the same period, and the population of the United States increased by 3%.

McKinley County's employment is more concentrated in service-producing industries (91%) and the wage and salary employment share of 76% is slightly lower than the state share of 77% and 2% higher than the national share, as shown in Tables 2 & 4. Table 3 shows employment levels by types: wage and salary (76%) and proprietor employment (24%). The remainder of this analysis focuses only on wage and salary employment for the private sector.

In 2023, 67% of all workers in McKinley County were employed in the private sector, much lower than state levels of private sector employment (79%) and significantly lower than national private employment levels (86%). McKinley County's employment by employer type is shown in Table 5 with state, federal and local government employing 33%.

Comparatively, the private sector in McKinley County is employing less workers compared to the share by state and national figures.

Per capita annual wages for McKinley County in 2023 (\$44,320) was 76% of the state of New Mexico average (\$58,110) and 61% of the national average (\$72,357), shown in Figure 1¹⁴. The growth rate of per capita annual wages in McKinley County between 2019 and 2023 (18%) was lower than the growth in annual wages for New Mexico (24%) and the growth of national averages (22%) during the same period.

The total number of wage and salary jobs in McKinley County in 2023 was 20,648. Between 2019 and 2023, total employment in McKinley County decreased by 5%, compared to the state, which saw an increase of 2.3%, and the nation, which increased by 3%, as shown in Table 6.



Economic Base Analysis

For this report, an LQ greater than 1.0 with respect to U.S. employment is considered a base industry. The sectors with LQ greater than 1.0 have been shaded green. All LQ calculations are compared to national employment data. All tables after Table 7 focus only on private wage and salary employment.

Table 7 shows LQ calculation by employer type, highlighting government activities' importance to McKinley County's economy. McKinley County heavily relies on government employment particularly, state and local government. The large LQ for State government and local government employment (3.88, 2.12, and 1.34 in 2023 respectively) reflects a high level of employment at the state, local and federal government facilities, national parks, schools, historical districts and other tourist centers in McKinley County. As important national facilities, these federal activities export services beyond McKinley County and can be classified as a base industry in the county. The small LQ for private employment (0.66 in 2023) in McKinley County reflects a low level of employment by the retail and service industry, construction, and transportation and logistics industry compared to the national average. State and Local Government and Federal Government even though has a location quotient of 3.88, 2.12, and 1.34 respectively, given that local governments collect taxes from residents to provide services to the community, including employment, cannot be considered as the base industry. Following this practice, Local government for McKinley County will be regarded as a non-base industry even though it had an LQ of 2.04 in 2023. State and Federal government jobs can be classified as base industries for McKinley Counties since wages and other benefits of these workers are not paid from the local taxes.

McKinley County's private sector wage and salary employment are shown in Table 8 by NAICS Sector from 2019 to 2023. Retail trade, accommodation and food services, and

Healthcare and social services, stand out as the base industries for McKinley County, with 2023 LQs of 1.57, 1.48, and 1.2.

A more detailed analysis of industry subsegments also reveals significant industry concentrations in jewelry and silverware manufacturing and wholesale, as well as above average concentrations in transit and ground passenger transportation, and radio broadcasting.

In economic base studies, it is common to calculate an export-based employment multiplier. This employment multiplier is obtained by dividing total employment in McKinley County by total employment in the base industries. In McKinley County, the multiplier for 2023 is equal to 1.59 (19,823/12435). This ratio suggests that the addition of one (1) base industry job in McKinley County would increase total jobs in the community by 1.59. The export base multiplier (1.59) calculated above reinforces the importance of base (exporting) industries to the economy of McKinley County. This employment multiplier is not to be compared to employment multipliers included in economic impact analysis tools, including RIMS, REMI, and IMPLAN. In the case of McKinley County, potential double-counting occupations may result in an upward bias of the multiplier, given that farm employees often have more than one occupation.

Local economic development policy actions, such as creating industrial parks, tax abatement, and financing, and workforce development projects, are often used by local communities to expand an area's economic base. A community economic development plan should include the appropriate combination of policies usually resulting from public and private sector interaction.

More detailed industry data is provided in the appendix for further analysis and interpretation.
