The ACSA Model

Putting together a strong SBIR proposal takes time. Drawing on the resources and expertise of NM FAST, ACSA provides a guided, structured track of support, from registration to submission. Throughout the 11-week program, participants receive guidance on areas such as selecting the most relevant topic area, preparing an accurate budget, and creating a complete proposal package that adheres to DoD requirements. Each week focuses on an aspect of proposal package development and culminates with a submission to the <u>Department of Defense (DoD) 2020.1 SBIR BAA</u>.

Weekly, participants can expect to:

- Attend a virtual meeting
- Complete a portion of their proposal package
- Receive feedback, guidance, and support from NM FAST

This ACSA agency-specific program focuses on the DoD's 2020.1 SBIR BAA. The <u>DoD SBIR program</u> funds across ten service components who look at technology and innovation across an array of specializations. Typically, DoD topic areas seek innovative ideas to solve real-world problems affecting the warfighter. Because of this, DoD topic areas tend to be very narrow in scope, and your ultimate customer (and Phase III) will be the DoD.

However, both Navy and Air Force have recently allowed for "open topic" areas where they will review any type of technology or innovation that might align with their needs as an organization. Special consideration will be given towards these topics during the cohort.

Through the ACSA program, you'll receive targeted support on the following areas of proposal development:

- Registrations
- Executive summary & quad chart
- Topic matching
- Letter(s) of support
- Forms
- Grant writing
- Budget creation

We will facilitate a meeting or phone call with the appropriate DoD topic author, conduct a professional review of your completed proposal package, and be on-call during the submission process.

Requirements include:

SBIR Program Eligibility:

- Having 500 or fewer employees;
- Being independently owned and operated and organized for profit;
- Having your principal place of business in the U.S.;
- Being at least 51% owned by U.S. citizens or lawfully admitted permanent resident aliens;
- Performing all work within the U.S.;
- Having the Principal Investigator (PI) spend more than one-half of their time employed by the proposing firm; and,
- Having a minimum of two-thirds of the research work performed by the proposing firm in Phase I and one-half in Phase II.

To participate in ACSA, additional requirements must be met:

- Business must be based in New Mexico
- Business cannot have won a SBIR/STTR from DoD in the past three years; and
- Business must commit to submitting a DoD SBIR proposal.




