

RURAL ENERGY FOR AMERICA PROGRAM APPLICATION CHECKLIST TOTAL PROJECT COST OVER \$200,000

This checklist is a tool to help ensure your application is complete prior to the established deadline and to be considered for competition. Resource links and Federal Forms for the application are referenced below. Applicant must have a Unique Entity Identifier (UEI) or a Dun and Bradsteet Universal Number System (DUNS) number corresponding to the tax identification /social security number of the applicant entity. Applicants must register in the SAM (www.sam.gov) prior to submitting an application. Upon successful registration, a CAGE Code is assigned and must remain active until the project is completed and funds have been released. (See SAM Quick Start Guide for further instructions)
